Order

Sri Ch. Poorna Kumar has filed second appeal dated **17-02-2020** which was received by this Commission on **17-02-2020** for not getting the information sought by him from the Public Information Officer/ O/o the Director of PH&FW, Hyderabad and the First Appellate Authority/ O/o the Director of PH&FW, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **29-10-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

ఎంత చేకూర్చబడ్డారో మరియు మరియు RTI ACT
ను మార్చి/2017 వారికి మరియు మరియు మరియు మరియు
తగిన సమాచారం తెలపాలని

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **02-12-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The appellant is absent. The PIO/ Mrs.Leona Nelson, Deputy Director, NPCB, O/o the Director of Public Health & Family Welfare, Hyderabad is present and through affidavit stated that the information sought was forwarded to the DM &HO, Hanamkonda for further action. The PIO further stated that vide Rc.No.Esst/DM&HO.Wgl(U)/Spl/2020, dated.25-02-2020 the DM &HO, Warangal Urban has replied that the information sought by the appellant is with Sri Harish Raj, the then DMHO, Warangal District and the same has not handed over the file to their office. The PIO also filed a copy of the letter.

The PIO/Sri B.Yadagiri, Administrative Officer, O/o the DM & HO, Warangal Urban District is present and through affidavit stated that the then DM&HO, Warangal Urban and the then Jr.Assistant Sri G.Pranav has not handed over the recruitment file to their office.

Heard the PIO's and perused the material papers available on record. The Commission took a serious view against the then PIO/Sri B.Harish Raj presently working as Incharge DM & HO, Mahabubabad for not furnishing the sought file to their office. The Commission directs to issue **Show Cause Notice** to the then PIO/ Sri B.Harish Raj and also the present PIO/O/o the DM &HO, Warangal Urban District for not furnishing the information to the appellant.

The Commission also directs the present PIO/ O/o the DM &HO, Warangal Urban District to once again send a remainder to the then DM&HO, Warangal Urban and collect the information and furnish the same to the appellant within one week from the date of receipt of this order and to report compliance to the Commission. The order on **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
