## **Order**

Sri Arun Kumar Tyagi has filed complaint dated **18-02-2020** which was received by this Commission on **20-02-2020** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Kapra Mandal, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **26-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. Kindly provide me information how many land grabbing Act case on me, for encroachment on government land case are registered as per your records with facts.
2. Is I am a land grabber of government land as per your records.

The Public Information Officer through Memo No. B/1007/2019 dated -09-2019 informed to the complainant that the sought information is not clear and specific.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **19-01-2022 at 10.30 AM.**

The Case is heard on 19-01-2022. The complainant is absent. The PIO/Sri K.Rajender, Naib Tahsildar, Kapra Mandal, Medchal Malkajgiri District is present and stated that vide letter No.B/1007/2019, dated. -09-2019 the complainant was informed that the sought information is not clear and specific.

Heard the PIO and perused the material papers available on record. The Commission observed that the information sought by the complainant is not clear and also not specific.

Hence the Commission advises the complainant to file a separate 6(1) application and seek specific information from the concerned PIO. Accordingly, the complaint is closed.
