Revised Order

Sri Arun Kumar Tyagi has filed complaint dated **18-02-2020** which was received by this Commission on **20-02-2020** for not getting the information sought by him from the Public Information Officer/ The District Revenue Officer, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **14-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Is the present Medchal - Malkajgiri Collector Office is existing in government land or in rented land?**
- 2) If rented in private land what is the rent for every month & from where rent, who is paying and then please provide me rental agreement copy & other relevant.**

The Public Information Officer through Lr. No. A3/RTI/398/2019 dated 16-08-2019 directed the Section Superintendent-B of their office to furnish available information to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-10-2021 at 10.30 AM.**

The Case was heard on 05-10-2021. The complainant is absent. The APIO/Sri B.Kiran Kumar, Senior Assistant, O/o.the District Collectorate, Medchal Malkajgiri District is present and stated that vide letter No.B1/2226/2019, dated.04-10-2019 the information was furnished to the complainant. The PIO further submitted a copy of the information but failed to provide the copy of the postal receipt as a proof of dispatch.

Heard the APIO and perused the material papers available on record. The Commission observed that though the PIO has agreed that they furnished the information to the complainant but failed to provide any proof of dispatch.

Hence the Commission directs the PIO to furnish the information once again to the complainant within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
