Order

Ms. A. Laxmi has filed complaint dated **20-02-2020** which was received by this Commission on **22-02-2020** for not getting the information sought by him from the Public Information Officer/ O/o the Director of Mines & Geology Department, Jagtial District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **24-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

2. ~~అటంకు~~ పైన పేర్కొనబడిన సర్వే నెంబర్ లో, నేటి, మరెయి, మల్లి, కలికత్త పరఖస్తు చేసుకోవడానికి వివరాలు; అవగా, పరఖస్తుల యొక్క చిరునామా, కాఫర్ నెట్, ఫీడ్ సమీప బాధం, మరియు మరెయిల యొక్క అనుమతి పొందన వల్ల లయిక్ల జాక్స కాఫర్ నెట్, ఫీడ్ సమీప బాధం, నాచిరునామాలు పంపగలకు.

Stating that the complainant did not get any response from the Public Information Officer, she preferred the complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

The Public Information Officer through Letter dated 18-03-2020 informed to the Commission that they have requested the complainant through Letter dated 05-09-2019 to personally collect the photo copies of the information paying the fixed charges for Xerox copies, but the complainant has not visited their office till date in the matter.

In view of the above, notice is issued to both the parties to attend for hearing on **16-03-2022 at 10.30 AM.**

The case is heard on 16-03-2022. The complainant is absent. The PIO/Sri Vijay Kumar Rathod, Assistant Director of Mines & Geology, Jagtial District is present and stated that vide letter No.54/RTI/2005/2016, dated.05-09-2019 part information was furnished to the complainant and for remaining information the complainant was informed to collect the information by paying the Xerox charges. The PIO also filed a copy of the information along with the copy of the postal acknowledgement.

The Commission perused the material papers available on record and observed that the PIO has furnished the part information and for remaining information informed the complainant to receive the information after paying the requisite charges.

The Commission directs the PIO to furnish the remaining information to the complainant after collecting the requisite charges from the complainant and to report compliance to the Commission.

With the above direction, the complaint is closed.
