Order

Sri Syed Khasimhussain has filed second appeal dated **05-01-2021** which was received by this Commission on **08-01-2021** for not getting the information sought by him from the Public Information Officer/ O/o the GM, SCCL., Kothagudem Area, Bhadradri – Kothagudem District and the First Appellate Authority/ O/o the GM, SCCL., Kothagudem Area, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **06-09-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Order No.7600007664 Dated:30.01.2019 issued for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-II of over burden with hired HEMM in combination with not more than 8 nos of conventional equipment at JVR OC-II,Project SCCL Kothagudem area was issued to M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 by GM(CM) SCCL Kothagudem. As per Enquiry No.E111800231 dated:01.09.2018, M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 was uploaded offer through e-procurement. The Xerox copy of offer uploaded through e-procurement by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 against Enquiry No.E111800231 dated:01.09.2018 may please be provided.
- 2) During course of tendering each contractor who submitting quotations for OBR work have to submit an under taking in A2 or A3 format stating that they should not deploy/engage contract labour in the OBR work and they will carry out with their workers with machinery only. The Xerox copy of under taking submitted by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 to SCCL, Kothagudem for Order No.7600007664 Dated:30.01.2019 may please be provided.
- 3) Order No.7600008293 Dated:04.06.2020 issued for the work of drilling, excavation, transportation, loading, dumping etc., at KHG OC Project, Bellampalli area of over burden with hired HEMM in combination with of conventional equipment was issued to M/s GRN Pvt Ltd, Nellore -524003 by GM(CM) SCCL Kothagudem. As per Enquiry No.E111900319 dated:13.11.2019, M/s GRN Pvt Ltd, Nellore -524003 was uploaded offer through e-procurement. The Xerox copy of offer uploaded through e-procurement by M/s GRN Pvt Ltd, Nellore -524003 against Enquiry No.E111900319 dated:13.11.2019 may please be provided.
- 4) During course of tendering each contractor who submitting quotations for OBR work have to submit an under taking in A2 or A3 format stating that they should not deploy/engage contract labour in the OBR work and they will carry out with their workers with machinery only. The Xerox copy of under taking submitted by M/s GRN Pvt Ltd, Nellore -524003 to SCCL, Kothagudem for Order No.7600008293 Dated:04.06.2020 may please be provided.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **04-11-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The Public Information Officer through Letter dated 16-11-2020 enclosed a letter dated 10-11-2020 and requested the GM (Material Procurement) to furnish the information immediately, so as to enable to forward the same to the applicant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer and did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-02-2022 at 10.30 AM.**

The Case is heard on 23-02-2022. The appellant is absent. The PIO/Sri D,Srinivas, Dy.GM, Corporate, Kothagudem Area, Bhadradi Kothagudem District is present and stated that vide Ref No.CRP/RTI-PIO/3144/198, dated.04-02-2021 the information sought by the appellant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
