## Order

Sri S. Venkatesh has filed complaint dated **03-03-2020** which was received by this Commission on **03-03-2020** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Medchal Mandal, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **19-12-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **19-01-2022 at 10.30 AM.**

The Case is heard on 19-01-2022. The complainant is present and stated that PIO has not furnished the information. The APIO/Sri Ch.Chandrakanth, Girdawar, Medchal Mandal, Medchal Malkajgiri District is present and stated that the information sought by the complainant is furnished recently but failed to provide the copy of the proof for furnishing the information.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has failed to furnish the information to the complainant as per the provisions of RTI Act.

The Commission took a serious view against the present and the then PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005 and directed to issue **Show Cause Notice** to the present and the then PIO for the delay caused in furnishing the information.

The Commission also directs the PIO to furnish the information to the complainant within one week through RPAD and to report compliance to the Commission. The order on **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
