## **Order**

Sri Mohd Fareeduddin has filed second appeal dated **11-03-2019** which was received by this Commission on **11-03-2019** for not getting the information sought by him from the Public Information Officer/ O/o the District Educational Officer, Rangareddy District and the First Appellate Authority/ the District Educational Officer, Rangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-01-2019** before the Public Information Officer/ O/o the District Collector, Rangareddy District requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. How many application are submitted for support in S.S.A. District Office. Please furnish the detail report.
2. How many applications are accepted for sanction the support. Please furnish the detail report.
3. How many applications are rejected what are the reasons. Please furnish the detail report.
4. How many Vidya VolunTERS are selected and each Madarsa how many Vidya VolunTERS are sanctioned.

Please furnish the information below mentioned proforma:

5. As per the application one sentence mentioned in the subject. **To the children who are enrolled in our Madarsa for the year 2018-19.** Please explained and last one year back enrolled children's not eligible for support. Please furnish the detail.
6. As per the Guidelines of SPD verified before the sanction order for Madarsa Support. Please furnish the complete report below mentioned proforma.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **08-02-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-09-2021 at 10.30 AM.**

The Case is heard on 15-09-2021. The appellant is absent. The Public Information Officer is present. The Commission found that this case relates to Education Department. Hence the case is **adjourned.**

In view of the above, notice is issued to both the parties to attend for hearing on **22-02-2022 at 10.30 AM.**

The Case is heard on 22-02-2022. The appellant is present and through affidavit stated that the PIO has furnished the information. The PIO/ Smt.Nandu Sukeshini, Assistant Director, O/o the District Educational Officer, Rangareddy District is present and stated that vide Lr.No.539/SSA-2/2019, dt.21-02-2019 the available information was furnished to the appellant. The PIO also filed a copy of information.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
