## Order

Sri Syed Khasimhussain has filed second appeal dated **03-03-2020** which was received by this Commission on **05-03-2020** for not getting the information sought by him from the Public Information Officer/ The Dy. GM (PER), SCCL., Manuguru Area, Bhadradi – Kothagudem District and the First Appellate Authority/ The GM(PER), SCCL., Manuguru Area, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-12-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Order No.7600007415 Dated:18.07.2018 issued for the work of drilling, excavation, transportation, loading, dumping etc., at M/s SUSHEE Infra & Mining Ltd of over burden with hired conventional equipment for the period of 18 months was issued to M/s SUSHEE Infra & Mining Ltd, Hyderabad-34. The date of commencement of work as per Order No.7600007415 Dated:18.07.2018 by the contractor may please be provided.
- 2) M/s SUSHEE Infra & Mining Ltd, Hyderabad-34 is also carrying out the work of drilling, excavation, transportation, loading, dumping etc., at M/s SUSHEE Infra & Mining Ltd Manuguru area with more than 100 contract labour from 01.08.2018. The Xerox copy of labour license submitted to GM, SCCL, Manuguru by M/s SUSHEE Infra & Mining Ltd, Hyderabad-34 obtained from ALC@,Hydrabad under CL(R&A) Central rules,1971 may please be provided.
- 3) M/s SUSHEE Infra & Mining Ltd, Hyderabad-34, are engaged more than 100 workers from 01-08-2018 to 30-11-2019 in the work of drilling, excavation, transportation, loading, dumping etc., at SCCL MNG OCP-II, Manuguru. As per the Industrial employment (standing orders ) Act 1946, M/s SUSHEE Infra & Mining Ltd, Hyderabad-34 should get certified copy of standing orders of their company under Industrial employment (standing orders ) Act 1946. The contractor shall not engaged contract labour such as OBR work with contract labour prohibited under section -10(1) of CL (R&A) Act 1970, and SO 2063 Dated:21-06-1988. The Xerox copy of certified copy of standing orders of their company under Industrial employment (standing orders ) Act 1946 submitted by M/s SUSHEE Infra & Mining Ltd, Hyderabad-34 to GM,SCCL Manuguru Area may please be provided.
- 4) M/s SUSHEE Infra & Mining Ltd, Hyderabad-34 are engaged more than 100 workers from 01-08-2018 to 30-11-2019 in the work of of drilling, excavation, transportation, loading, dumping etc., at SCCL. MNG OCP –II,Manuguru. As per the Industrial employment (standing orders ) Act 1946, M/s SUSHEE Infra &

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **18-01-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the Public Information Officer and did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The Public Information Officer through Letter dated 13-05-2020 informed to the appellant that for point No. 5,11,13,15 to 22 are being provided along with copies and remaining information could not be provided.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of "Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is present and stated that the PIO has furnished the complete information. The PIO/Sri S.Ramesh, Dy.General Manager, O/o the SCCL, Manuguru Area, Bhadradri Manuguru District is present and stated that vide letter MNG/PKOC/WO-14/1889, dated. 22-04-2020 the available and held information was furnished to the appellant through registered post. The PIO further submitted a copy of the information along with the copy of the outward register as a proof of dispatch.

Heard both the parties and perused the material papers available on record. The Commission observed that though the PIO has agreed that the information was furnished to the appellant through registered post but failed to provide the copy of the postal acknowledgement. However the PIO has furnished the information to the appellant before the Commission.

Since the information is furnished, the appeal is closed.
