Order

Sri D. Srinivas has filed second appeal dated **05-03-2021** which was received by this Commission on **06-03-2021** for not getting the information sought by him from the Public Information Officer/ O/o the NIMS., Hyderabad and the First Appellate Authority/ O/o the NIMS., Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **16-12-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. NIMS Hospital నందు సేతుగుతున్న ఆడ్రెమాలిటి కిర్కాబులకు
Director NIMS గారి- ది. 29-10-2020 నాడు మరొక
ది. 11-11-2020 నాడు ప్రాథమిక కిర్కాబు గుర్తుం సేతుగుతు
సవకు కిర్కాబుపై అనుకున్న చర్యలు, చేసిన వివరాలు
సవకు వరకు, NIMS నందు ఆడ్రెమాలిటి చేస్తున్న
వారి అనుకున్న చర్యల వివరాలు విందగుతు.

2. Director, NIMS గారి- ది. 29-10-2020 మరొక
ది. 11-11-2020 నాడు గుర్తు కిర్కాబు వరకు సేతుగుతు.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **27-01-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **08-03-2022 at 10.30 AM.**

The case is heard on 08-03-2022. The appellant is present and submitted his affidavit stating that the information sought by him is received before the Commission. The PIO/ Sri P.Raj Kumar, Dy.Registrar, O/o the NIMS, Hyderabad is present and stated that the information sought by the appellant was furnished on the day of hearing.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information on the day of hearing.

The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
