## Order

Sri Sabir Ahmed Khan has filed second appeal dated **12-03-2020** which was received by this Commission on **16-03-2020** for not getting the information sought by him from the Public Information Officer/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad and the First Appellate Authority/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-12-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:



- ① furnish the photo state copy of letter no 12739/B1/2017 dt. 25.1.20 with attestation.
- ② furnish the photo state copy of memo no. 9946/B1/2017 dt. 17.11.20 with attestation.
- ③ furnish the photo state copy of DH&FW, T.S. dt. 16.12.2017. Com. 10089/E1.
- ④ photo state copy of note for dt. 9946/B1/2017 dt. 2.2.2018 with attestation.

The above information may please be furnished herein duly following the time limits prescribed under section 7(1) of RTI Act 2005.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **25-01-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The appellant is absent. The PIO/Smt.J.V.Vijaya lakshmi, Deputy Secretary to Government, Health Medical & Family Welfare Department, TS Secretariat, Hyderabad is present and stated that vide Letter No.9645/B/2019, dated.23-11-2020 the information sought by the appellant was furnished through registered post. The PIO also filed a copy of the information along with the copy of the postal acknowledgment.

Heard the PIO perused the material papers available on record. The Commission observed that PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
