Order

Sri PPS Hariprasad has filed complaint dated **19-03-2020** which was received by this Commission on **21-03-2020** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Alwal Mandal, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **11-02-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Request for clarification under RTI Act
Building Permissions from GHMC Alwal -Need for NOC – Survey No 374, Kanajguc

GHMC Alwal Circle seems to be following the letter No 8/1016/2019dated 1.1 addressed to them by the then Tahasildar, Malkajgiri Mandal (copy enclosed) for the p of determining the need for NOC for considering Building permissions in Survey No 374

Copy of Pahani showing Survey No 374 as PATTA LAND recently certified by you for a plot owner in December last year does not appear to satisfy them. (copy enclosed)

I request you to kindly clarify whether or not NOC is still essential for granting b permissions.in Survey No 374.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **18-01-2022 at 10.30 AM.**

The Case was heard on 18-01-2022. The complainant is absent. The PIO/Smt.S.Renuka Devi, Naib Tahsildar, Alwal Mandal, Medchal Malkajgiri District is present and stated that a letter Lr.No.B/45/2022, dated.10-01-2022 the available information was furnished to the complainant through registered post. The PIO further submitted a copy of the letter before the Commission along with the copy of the postal receipt.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information after the receipt of the notice from the Commission. The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
