Order

Sri K. Madhusudan Reddy has filed second appeal dated **15-12-2019** which was received by this Commission on **13-01-2020** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Ghatkesar Mandal, Malkajgiri, Medchal – Malkajgiri District and the First Appellate Authority/ The Revenue Divisional Officer, Keesara Division, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-07-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

2. సర్టిఫికేట్ నెం: 309, 310, 311, 386, 398, 399, 400 మరియు 422 యొక్క టిప్పాని (Tippani) ప్రతులు.

The Public Information Officer through Endorsement No. B/RTI/1759/2019 dated 10-07-2019 furnished the available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **19-08-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **19-01-2022 at 10.30 AM.**

The Case was heard on 19-01-2022. The appellant is present and stated that the PIO has furnished only part information. The PIO/Sri Ch.Bhaskar Reddy, Naib Tahsildar, Ghatkesar Mandal, Medchal Malkajgiri District is present and stated that vide letter Lr.No.C/RTI/23-1/2022, dated.18-01-2022 the available information was furnished to appellant and for remaining information vide Lr.No.C/RTI/23-1/1/2022, dated.18-01-2022 transferred the 6(1) application to the Assistant Director, Survey & Land Records, O/o the Collector, Medchal Malkajgiri District to furnish the information to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information after the receipt of notice from the Commission. The Commission took a serious view against the present and the then PIO/O/o the Tahsildar, Ghatkesar Mandal, Medchal Malkajgiri for not furnishing the held information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005 and directed to issue **Show Cause Notice** to the present and the then PIO for the delay caused in furnishing the information. The appellant also claims that he has not received the certified copy of the information.

Hence the Commission directs the PIO/Naib Tahsildar, Ghatkesar Mandal, Medchal Malkajgiri to furnish the certified copy of the information to the appellant within one week through RPAD and the PIO/ Assistant Director, Survey & Land Records, O/o the Collector, Medchal Malkajgiri District is also directed to furnish the information to the appellant within one week through RPAD and to report compliance to the Commission. The order on **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
