Order

Sri Syed Khasimhussain has filed second appeal dated **12-05-2020** which was received by this Commission on **22-05-2020** for not getting the information sought by him from the Public Information Officer/ The Dy. GM (PER), SCCL., Kothagudem Area, Bhadradri – Kothagudem District and the First Appellate Authority/ The GM(HRD), SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **18-01-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) As per letter No.KGM/PER/RTI/IV/101 Dated:06.01.2020,letter No.KGM/JVROC/ WO/46/33 Dated:31.12.2019 was submitted to DGM(PER) & PIO,SCCL Kothagudem area by Project officer, JVR OC-I and JVR OC-II SCCL Kothagudem area (Sattupally). In the last para of letter No. KGM/JVROC/ WO/46/33 Dated:31.12.2019 it was mentioned that for points-4,5,6 & 15, as the data is huge, it may take more time to collect the copies of documents, collection of information is under progress. The date of providing information for points-4,5,6 & 15 as stated by Project officer, JVR OC-I and JVR OC-II SCCL Kothagudem area (Sattupally) may please be provided.
- 2) In letter No.KGM/JVROC/ WO/46/33 Dated:31.12.2019, Annexure –IV was provided. In Annexure –IV the names of 73 local persons and 526 staff numbers deployed by M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34 for JVR OC-II project ,KGM area with their names, designation along with aadhar card numbers and bank account numbers was provided. The EPF/CMPF account numbers of 73 local persons and 526 staff numbers may please be provided.
- 3) Order No.7600007644 dated:30.01.2019 issued to M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34, for the work of drilling, excavation, transportation, loading, dumping etc., at SCCL JVR OCP-II, Kothagudem. The details of quantity of diesel supplied by SCCL to M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34,as per clause -1.4 of Order No.7600007644 dated:30.01.2019 from 01.03.2019 to 31.01.2020 monthly wise may please be provided.
- 4) The proofs of compliance of clause-1.9© of Order No.7600007644 dated:30.01.2019 by M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34, for the months of November and December,2019 may please be provided.
- 5) As per rule -52 of mines act,1952, M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34have to pay annual leave with wages to their workmen.The documentary evidence of compliance rule 52 of mine Act,1952 by M/s MAHALAXMI INFRACONTRACT PVT.LTD for the period from 01-02-2019 to 31-12-2019 for the work of drilling, excavation, transportation, loading, dumping etc. at work of drilling, excavation, transportation, loading, dumping etc., at SCCL JVR OCP-II, KOTHAGUDEM, may please be provided.
- 6) The proofs of compliance of clause-1.6 (j) of Order No.7600007644 dated:30.01.2019 by M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34, for the months of November and December,2019 may please be provided.
- 7) As per letter No.KGM/FAD/B/1323 Dated:23.08.2019 by finance manager, SCCL,KGM area to PIO,SCCL KGM area, the finance manager, SCCL,KGM area was submitted that the information is laborious and available. The Xerox copies of documents enclosed by M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34, as per clause-1.6 (j) of order No.7600007644 dated:30.01.2019 for the payment of monthly bills of November and December,2019 may please be provided.

The Public Information Officer through Letter dated 23-01-2020 requested the POJVRO (Deemed PIO), Kothagudem Area to furnish the information as required by the applicant, at the earliest on or before 10-02-2020 under intimation to their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **20-02-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of “Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is present and through affidavit stated that he has received the information on the day of hearing. The PIO/ Sri P.Sammuel Sudhakar, Dy.General Manager(Personnel), O/o the SCCL, Kothagudem Area is present and stated that vide letter Ref No.KGM/PER/RTI/I/2124, dated.27-04-2020 the information was furnished to the appellant through registered post. The PIO further submitted a copy of the information along with the copy of the acknowledgement. The FAA/Sri Ch.Narasimha Rao, General Manager, SCCL, Kothagudem area is present and stated that the information was furnished to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
