## **Order**

Sri Syed Khasimhussain has filed second appeal dated **12-05-2020** which was received by this Commission on **22-05-2020** for not getting the information sought by him from the Public Information Officer/ The Dy. GM (PER), SCCL., Kothagudem Area, Bhadradi – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **21-10-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) LOI Order No.CRP/CM/E111800231/49/22 Dated:17.12.2018 issued for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-I EXPANSION of over burden with hired HEMM in combination with conventional equipment at JVR OC-II Project ,SCCL Kothagudem area was issued to M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34. The date of commencement of work as per LOI Order No.CRP/CM/E111800231/49/22 Dated:17.12.2018 by the contractor may please be provided.
- 2) M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34 is also carrying out The work of drilling, excavation, transportation, loading, dumping etc., at JVR OCP-II SCCL Kothagudem area with more than 100 contract labour from 01.02.2019.The Xerox copy of labour license submitted to GM, SCCL, Kothagudem area by M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34 obtained from ALC@,Hydrabad under CL(R&A) Central rules,1971 may please be provided.
- 3) M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34, are engaged more than 100 workers from 01-02-2019 to 30-10-2019 in the work of drilling, excavation, transportation, loading, dumping etc., at SCCL JVR OCP-II, Kothagudem. As per the Industrial employment (standing orders ) Act 1946, M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34 should get certified copy of standing orders of their company under Industrial employment (standing orders ) Act 1946. The contractor shall not engaged contract labour such as OBR work with contract labour prohibited under section -10(1) of CL (R&A) Act 1970, and SO 2063 Dated:21-06-1988. The Xerox copy of certified copy of standing orders of their company under Industrial employment (standing orders ) Act 1946 submitted by M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34 to GM,SCCL Kothagudem Area may please be provided.
- 4) M/s SUSHEE Hitech Project Pvt Ltd, Hyderabad-34 are engaged more than 100 workers from 01-02-2019 to 30-10-2019 in the work of of drilling, excavation,

### ***More (13) points.***

The Public Information Officer through Letter dated 26-10-2019 requested the POJVRO-II (Deemed PIO), Kothagudem Area to furnish the information as required by the applicant, at the earliest on or before 10-02-2020 under intimation to their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **16-12-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of "Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of "Singareni Formation Day Celebrations to be is celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is present and through affidavit stated that he has received the information on the day of hearing. The PIO/ Sri P.Sammuel Sudhakar, Dy.General Manager(Personnel), O/o the SCCL, Kothagudem Area is present and stated that vide letter Ref No.KGM/PER/RTI/IV/101, dated.07-01-2020 the information was furnished to the appellant through registered post. The PIO further submitted a copy of the information along with the copy of the acknowledgement. The FAA/Sri Ch.Narasimha Rao, General Manager, SCCL, Kothagudem area is present and stated that the information was furnished to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
