Order

Sri D. Srinivas has filed second appeal dated **22-03-2021** which was received by this Commission on **25-03-2021** for not getting the information sought by him from the Public Information Officer/ O/o the NIMS., Hyderabad and the First Appellate Authority/ O/o the NIMS., Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **11-01-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

3. 2016-2020 సంవత్సరాలకు అధికారిక పబ్లిష్, వివరాలు, ఏకాంకి వారికా పంపగలరు.

The Public Information Officer through Letter dated 03-02-2021 requested the Public Information Officer/ Finance Controller, NIMS., to send the relevant information/ certified copies of required information of the application.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **13-02-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 23-02-2021 informed the concerned Public Information Officer/ Incharge Finance Controller, NIMS., to submit the information immediately for the application.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **08-03-2022 at 10.30 AM.**

The case is heard on 08-03-2022. The appellant is present and stated that the PIO has not furnished the information. The PIO/ Sri P.Raj Kumar, Dy.Registrar, O/o the NIMS, Hyderabad is present and stated that vide letter Rc.No.RTI/PIO/2021, dated.04-03-2022 the appellant was informed that the information sought by him is huge and voluminous and it is related to period of 4 years hence requested him for verification of records and select the information and take a photo copy of the same.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has called the appellant for verification of records but with an abnormal delay.

The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to once again call the appellant for verification of records as per Section 2(j) of RTI Act by issuing a prior intimation to the appellant and furnish the sought information within one week and to report compliance to the Commission.

With the above direction, the appeal is closed.
