Order

Sri M. Muthyalu Goud has filed complaint dated **05-06-2020** which was received by this Commission on **06-06-2020** for not getting the information sought by him from the Public Information Officer/ The District Revenue Officer, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **Nil** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **18-01-2022 at 10.30 AM.**

The Case was heard on 18-01-2022. The complainant is present and stated that the PIO has not furnished the information. The PIO/Sri D.Venugopal Reddy, Panchayat Secretary, Kachavani Singaram Gram Panchayat, Ghatkesar Mandal, Medchal Malkajgiri District is present and stated that the 6(1) application filed by the complainant was not received by their office and hence they did not furnish the information. The PIO further requested the Commission to provide them 10 days to furnish the information to the complainant.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO/ Panchayat Secretary, Kachavani Singaram Gram Panchayat, Ghatkesar Mandal, Medchal Malkajgiri District to furnish the information to the complainant within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
