Order

Sri J. Raghuma Chary has filed complaint dated **31-03-2021** which was received by this Commission on **06-04-2021** for not getting the information sought by him from the Public Information Officer/ O/o the District Hospital, Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **27-02-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

3. మా ఆసుపత్రిలో ఘట్ కార్యక్రమాలకు ప్రోత్సాహం మరియు కార్యక్రమ రంగులకు సంబంధించి మేము వివరాల కొరకు ఆస్తి చొప్పులు ప్రస్తుతం అందుబాటులో ఉన్నాయి.

గృహం దుస్థితిగా దా.10/ల గుర్తులు నేటికే అందుబాటులో ఉన్నాయి. ఆన సమాచారం కొరకు ఆస్తి చొప్పులు ప్రస్తుతం అందుబాటులో ఉన్నాయి.

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-03-2022 at 10.30 AM.**

The Case is heard on 23-03-2022. The complainant is absent. The PIO/ Dr.S.Sarala, Medical Superintendent, District Hospital, Kothagudem, Bhadradri Kothagudem District is present and stated that vide letter Rc.No.E.249/RTI-2005/DHK/2021, dated.05-03-2021 and also vide letter dated.22-03-2022 the complainant was called for verification of records but since the complainant did not respond they were unable to furnish the information. The PIO also filed a copy of the letter but failed to provide the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to once again call the complainant for verification of records as per Section 2(j) of RTI Act by issuing a prior intimation to the complainant and furnish the sought information within one week and to report compliance to the Commission.

With the above direction, the complaint is closed.
