Order

Ms. T. Suseelamma has filed second appeal dated **16-06-2020** which was received by this Commission on **16-06-2020** for not getting the information sought by him from the Public Information Officer/ O/o the Commissioner of HM&FW Department, Koti, Hyderabad and the First Appellate Authority/ O/o the Commissioner of HM&FW Department, Koti, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **12-12-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

While dealing with the above cited instructions it is evident to state that some mandatory instructions were discriminatorily given to D.M.H. to Karimnagar by the said Commissioner who had - Rules - Standli to infringe the said Statutory Rules of Conducting Enquiry against T. Suseelamma H.A (F) before imposing disciplinary action of removal from service as a rule which ought to be adhered to without any deviation.

Since there was an illegality and invalidity in every step of your skewed actions without following fundamental rules, you are, therefore, implored to kindly supply me the relevant and point-wise information within stipulated time and oblige.

Stating that the appellant did not get any response from the Public Information Officer, she filed 1st appeal dated **13-01-2020** before the First Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, she preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The appellant is absent. The PIO/ Smt.G.Vijaya, Assistant Director(FW), O/o the Commissioner of Health Medical & Family Welfare, Hyderabad is present and stated that vide letter U.O.Note.No.41/FW-Estt/2014, dated.13-12-2019 and U.O.Note.No.41/FW-Estt/2014, dated.28-01-2020 the available information was furnished to the appellant. The PIO further filed a copy of the information but failed to provide the copy of the postal acknowledgement.

Heard the PIO and perused the material papers available on record. The Commission observed that the though the PIO has agreed that the information was furnished to the appellant but failed to provide the proof of dispatch.

The Commission directs the PIO to furnish the information once again to the appellant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
