Order

Sri B. Dharma has filed second appeal which was received by this Commission on **23-06-2020** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Kapra Mandal, Malkajgiri, Medchal – Malkajgiri District and the First Appellate Authority/ The Revenue Divisional Officer, Keesara Division, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **17-01-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

పౌర సమాచార అధికారి కాప్రా మండల్ యం.ఆర్.ఓ. గారికి విషయము సర్వే నెం.321 ఖాస్రా వహానీ సర్టిఫైడ్ కాపీ ఇవ్వగలరు.
మీ వద్ద లేకపోతే ఆర్.డి.ఓ. కార్యాలయం నుండి తెప్పించి పూర్తి వివరాలతో ఇవ్వగలరు.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **24-02-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Notice dated 08-06-2020 directed the Public Information Officer and the appellant to appear for hearing on 16-06-2020 at 11.00 AM along with related records/ documents.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **19-01-2022 at 10.30 AM.**

The Case was heard on 19-01-2022. The appellant is present and stated that the PIO has not furnished the information. The PIO/Sri K.Rajender, Naib Tahsildar, Kapra Mandal, Medchal Malkajgiri District is present and requested the Commission to provide him one week to furnish the information to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has failed to furnish the information to the complainant as per the provisions of RTI Act.

The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission also directs the PIO to furnish the information to the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
