## Order

Sri E. Satyanarayana has filed second appeal dated **19-04-2021** which was received by this Commission on **22-04-2021** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Peddapalli District and the First Appellate Authority/ O/o the Director of Public Health & Family Welfare, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **21-01-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 2) మంథాని ఆసుపత్రి ప్రతి తుదికొంత భాగము నాను తీసుకున్న విన్నపాన్ని తీసుకున్న చర్యల వివరాలను ప్రకటించాలని తేదీ: 20-11-2020 రోజున విన్నపము తీసుకున్న చర్యల వివరాలను ప్రకటించాలని.
- 3) నిజామాబాద్ లోని ప్రభుత్వ ఆసుపత్రి, ఆసుపత్రి నాను తీసుకున్న విన్నపాన్ని తీసుకున్న చర్యల వివరాలను ప్రకటించాలని తేదీ: 20-11-2020 రోజున విన్నపము తీసుకున్న చర్యల వివరాలను ప్రకటించాలని.
- 4) మంథాని సీ.ఎం.ఆర్. కేంద్రాన్ని తీసుకున్న విన్నపాన్ని తీసుకున్న చర్యల వివరాలను ప్రకటించాలని తేదీ: 20-11-2020 రోజున విన్నపము తీసుకున్న చర్యల వివరాలను ప్రకటించాలని.

The Public Information Officer through Letter dated 01-02-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the Civil Hospital, Peddapalli with a request to furnish the available information to the appellant directly under intimation to their office.

The Public Information Officer through Letter dated 09-02-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **11-03-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated -03-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the Director of Public Health & Family Welfare, Hyderabad with a request to furnish the available information to the appellant directly under intimation to their office.

The First Appellate Authority through Letter dated -03-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ TVVP., Peddapalli with a request to furnish the available information for point no. 4 to the appellant directly under intimation to their office.

The First Appellate Authority through Letter dated -04-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the DM&HO., Karimnagar District with a request to furnish the available information for point no. 4 to the appellant directly under intimation to their office.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-03-2022 at 10.30 AM.**

The Case is heard on 23-03-2022. The appellant is present and through affidavit stated that the PIO has not furnished information for point No.4 of his 6(1) application dated. 21-01-2021. The PIO/ Dr.M.Kishore Kumar, Administrative Officer(I/C), O/o the DM & HO, Peddapalli District is present and stated that vide Letter No.RTI/265/2021, dated.09-02-2021 part information was furnished to the appellant and also vide letter Rc.No.Po/Malaria/246/2021, dated.16-02-2021 remaining information was furnished to the appellant. The PIO further submitted that for point No.4 of the 6(1) application was transferred to the PIO/O/o the TVVP Peddapally, District Hospital, Peddapally District to furnish the information directly to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the available information to the appellant and for point No.4 transferred the 6(1) application under Section 6(3) of RTI Act to the PIO/ O/o the TVVP Peddapally, District Hospital, Peddapally District to furnish the information directly to the appellant.

Hence the Commission directs the PIO/ O/o the TVVP Peddapally, District Hospital, Peddapally District to furnish the information directly to the appellant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
