Revised Order

Sri S. Shiva Kumar has filed second appeal dated **14-07-2020** which was received by this Commission on **18-07-2020** for not getting the information sought by him from the Public Information Officer/ O/o the Executive Engineer (Housing), Housing Board, Vinayaknagar, Nizamabad District and the First Appellate Authority/ O/o the Telangana Housing Board, M.J. Road, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **26-04-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. సిద్దిపేట జిల్లా మరియు పట్టణము, హైద్రాబాద్ రోడ్డు, అటవి శాఖ కార్యాలయము ప్రక్కన, హౌజింగ్ బోర్డు కాలనీలోని M.I.G.-II, H.No.1, విస్తీర్ణం 266 చ||గ|| గల ఇల్లు నా తండ్రి సిద్దిరాం మల్లయ్య తండ్రి రాచయ్య పేరున సాంక్షన్ అయినది. ప్రస్తుతము ఎవరి పేరున గలదు వాటి యొక్క పూర్తి వివరాలు సాంక్షన్ లెటర్, నోట్ ఫైల్, రిజిస్టర్డ్ డాక్యుమెంట్స్ మరియు మేము సమర్పించిన పత్రాలు, దరఖాస్తులు అన్నింటినీ అటెస్టేడ్ చేసి ఇవ్వగలరు. తేది:28.02.2019 నాడు ఇట్టి విషయములో దరఖాస్తు చేసినాను, అయినా ఇంత వరకు సమాచారం ఇవ్వలేదు.

The Public Information Officer through Letter dated 25-05-2019 information sought by the appellant cannot be furnished under section 8(1) of RTI Act, 2005.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **18-10-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 10-01-2020 informed to the appellant that the reply furnished by the Public Information Officer is holds good vide letter dated 25-05-2019.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **12-10-2021 at 10.30 AM.**

The Case was heard on 12-10-2021. The appellant is present and stated that the PIO has not furnished the information. The APIO/Sri S.Gangadhar Rao, Asst. Estate Officer, O/o the Executive Engineer, Telangana Housing Board, Nizamabad District is present and stated that vide Lr.No.3202/E1/RTI Act/EE-NZB/2019/133, dated.25-05-2019 the appellant was informed that the information sought by the appellant cannot be furnished under Section 8(1) of RTI Act, 2005. The APIO further submitted a copy of the letter before the Commission.

Heard the APIO and perused the material papers available on record. The Commission observed that the PIO has rejected the 6(1) application U/s.8(1)(j) of the RIT Act. The Commission did not accept the plea made by the PIO and directs the PIO to furnish the information to the appellant following the guidelines of Section 8, 9 and 10 of RTI Act within one week through RPAD and to report compliance to the Commission the

With the above direction, the appeal is closed.
