## **Order**

Sri T. Surender Reddy has filed second appeal dated **24-07-2020** which was received by this Commission on **25-07-2020** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Uppal Mandal, Malkajgiri, Medchal – Malkajgiri District and the First Appellate Authority/ The Revenue Divisional Officer, Keesara Division, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **18-03-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. ఉప్పల్, “నాగల చెరువు” (నల్ల చెరువు) నర్వె నెం.150, పూర్తి విస్తీర్ణము ధృవపర్చు ఆధారము.
2. నీటినిల్వ స్థిరీకరణ సామర్థ్యము నిర్ధారించిన నివేదిక చట్టబద్ధ నమాచారము.
3. FTL పరిధిలోని చెరువు ఇళం భూమిని ఆక్రమణలు చేయబడిన స్థలము నిర్ధారించిన నివేదిక నమాచారము.
4. FTL పరిధిలోని చెరువు ఇళం భూమిని ఆక్రమించిన వారి పేరు, ఆక్రమణ స్థలము విస్తీర్ణము, ఆక్రమణలో నిర్మించిన కట్టడాల నమాచారము.

The Public Information Officer through Letter dated 27-05-2020 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the Executive Engineer, North Tanks Division, Budda Bhavan, Hyderabad and the Public Information Officer/ Deputy Tahsildar, Uppal Mandal with a request to provide information directly to the applicant under intimation to their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **-07-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **19-01-2022 at 10.30 AM.**

The Case is heard on 19-01-2022. The appellant is present and stated that the PIO has furnished the information on the day of hearing. The PIO/ Sri Mohd Rafiuddin, Naib Tahsildar, Uppal Mandal, Medchal Malkajgiri District is present and stated that vide letter Lr.No.RTI/45-05/2022, dated.11-01-2021 the information was already furnished to the appellant but failed to provide the proof of dispatch. The PIO further stated that the information was again furnished to the appellant through registered post on 18-01-2022 through registered post and submitted a copy of the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant with an abnormal delay. The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
