## **Order**

Sri Mohd. Ashraf has filed complaint dated **21-07-2020** which was received by this Commission on **08-07-2020** for not getting the information sought by him from the Public Information Officer/ O/o the Director of PH&FW, Koti, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **17-06-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. నేను మీ కార్యాలయానికి తేది.27-05-2020 రోజున Sri. P.Shyam Babu Senior Assistant, O/o District Medical and Health Officer, Ashtabad లో filegal Suspension పై Complaint చేసినాను. వాటి పై మీరు తీసుకున్న చర్యల ప్రతులను నేటి పుత్ర తో పాటు ఇవ్వాలయి. (Copy Enclosed) ప్రస్తుత స్థితి తో పాటు Rule Position ను తెలుపగలయి.
2. ప్రభుత్వ నిర్దేశించిన గడవు & Hon'ble Supreme Court Order No.1912 of 2015 dated:16.02.2015 & ఖరారు 3 months complete కాకపోవడానికి గల reasons ను ఇవ్వాలయి.
3. Sri. P.Shyam Babu Senior Assistant, O/o District Medical and Health Officer, Ashtabad Suspension file నెంబర్.R.C.No.2/Esst/2019 లో suspension allowance FR 53 ప్రభుత్వ ఆదేశాలు & Hon'ble Supreme Court orders ప్రకారం ఇచ్చాకపోవడానికి గల reasons ను తెలుపగలయి & పాటు ఇవ్వగలయి.

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The complainant is absent. The PIO/ Mrs.Leona Nelson, Deputy Director, NPCB, O/o the Director of Public Health & Family Welfare, Hyderabad is present and stated that vide letter Rc.No.7284/RTIA/220-GAD, dated.10-03-2022 the information sought by the complainant was furnished through registered post. The PIO also filed a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the complainant with an abnormal delay.

The Commission took a serious view against Public Information Officer for not furnishing the information to the complainant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
