Order

Sri Mohd. Aleemuddin has filed second appeal which was received by this Commission on **05-05-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC, Chandanagar, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, GHMC, Serilingampally, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **17-11-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Kind attention to
The detail question as follow
1) Jam Enclousure here with a copy
of letter addressed to 20 slip
zone GHMC letter issued by Honble
Court LAKAYUKATA. let me know
Action Deem't taken?
2) Can you provide a copy of
change of name order from
ARJUN Devalal to Mthl Rajit
3) let me know why the detail
issuance of change of name
order?

(3) more points.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **22-12-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Notice dated 03-02-2021 directed the Public Information Officer and the appellant to appear for hearing on 15-02-2021 at 3.00 PM along with related records/ documents.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-03-2022 at 10.30 AM.**

The Case is heard on 09-03-2022. The appellant is absent. The PIO/ Sri P.Krishnamurthy, Town Planning Supervisor, GHMC, Circle – 21, Chandanagar, Seriglingampally Zone is present and through affidavit requested the Commission to provide them two weeks of time to furnish the information to the appellant.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Hence the Commission directs the PIO to furnish the information to the appellant within two weeks through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
