Order

Sri D. Srinivas has filed second appeal dated **07-05-2021** which was received by this Commission on **07-05-2021** for not getting the information sought by him from the Public Information Officer/ O/o the NIMS., Hyderabad and the First Appellate Authority/ O/o the NIMS., Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **19-02-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

 2. తేదీ: 02-06-2014 సుందీ నోటిఫికేషన్లకు NIMS కు రిజర్వ్ ఆఫీస్ రిపోర్టులు నడవ, ఆఫీస్ ఆఫ్ ఫైనాన్స్ అండ్ ఆడిట్ ఆఫీస్ నుండి NIMS కు వచ్చిన వివరాలు తెలియపరచగలరు.
 3. తేదీ: 02-06-2014 సుందీ నోటిఫికేషన్లకు NIMS ట్రెజరీ డివిజన్ కు Budget కాపీలు, వారి ఖాతా సేవల వివరాలు పంపగలరు. Pending Amount settlement వివరాల పంపగలరు.

The Public Information Officer through Letter dated 22-02-2021 requested the Public Information Officer/ Incharge Finance & Audit, NIMS., to send the relevant information/ certified copies of required information of the application.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **22-03-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **08-03-2022 at 10.30 AM.**

The case is heard on 08-03-2022. The appellant is present and stated that the PIO has not furnished the information. The PIO/ Sri P.Raj Kumar, Dy.Registrar, O/o the NIMS, Hyderabad is present and stated that vide letter Rc.No.RTI/PIO/2021, dated.04-03-2022 the appellant was informed that the information sought by him is relating to the period of 7 years record and also the information sought is not clear and specific, hence rejected to furnish the information

Heard both the parties and perused the material papers available on record. The Commission observed that the information sought by the appellant is not specific.

Hence the Commission advises the appellant to file a separate 6(1) application before the PIO and seek specific information. Accordingly, the appeal is closed.
