Order

Sri B. Laxman Rao has filed complaint dated **05-05-2021** which was received by this Commission on **10-05-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Mineral Development Corporation Ltd., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **30-03-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① గానుక నాపైటిల నిర్మాణముకు TSMDC వారి వెబ్సైట్ నియమ నిబంధనల 6.0 కాలిబ్ల Amendments, ఖాతాల్కు వివరాలు తెలుపుతూ attached copies ఇవ్వగలరు.
- ② TSMDC అనుమతులే సమీపముకు గిరిజన గానుక నాపైటిలైన, కత్తిగూడెం - c కత్తిగూడెం, అన్నారం, చిన్నరావిగూడెం, విజయనగరం - 2 లాంపుల యొక్క Dispatched / Balance Quantity వివరాలు 30-03-2021 వరకు తెలుపగలరు.
- ③ అన్నారం, చిన్నరావిగూడెం, విజయనగరం - 2, కత్తిగూడెం లాంపుల యొక్క CC కెమెరా ఫుటేజీని 31-03-2021 నుండి తమని నాకు సహాయం ఇచ్చు 30 లాంపుల గానుక రూపా 01-05-2021 మధ్యన గల లాంపుల నుండి, ఏదేని మూడు లాంపుల గానుక Loading, CC ఫుటేజీ రికార్డును CD/DVD రూపంలో ఇవ్వగలరు.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM.**

The Case was heard on 04-01-2022. The complainant is absent. The PIO/ Sri N.Yellaiah, DGM(Mines), O/o the Telangana State Mineral Development Corporation Ltd., Bhadradi Kothagudem District is present and stated that vide letter No.TSMDC/BDDKtdm/Sand/RTIA/2021-22/26, dated.29-04-2021 except for CC Footage report remaining information was furnished to the complainant. The PIO further submitted a copy of the information along with the copy of postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission did not accept the plea made by the PIO and observed that the PIO has not furnished complete information to the complainant.

Hence the Commission directs the PIO to furnish the complete information to the complainant within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
