Order

Sri Alok Barua has filed complaint dated **01-05-2021** which was received by this Commission on **11-05-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Tourism Development Corporation, Himayathangar, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **02-03-2021** before the Public Information Officer/ O/o the Chief Secretary to Government, T.S. Secretariat, Hyderabad requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- a) Kindly supply the information that Durgaram Chervu Cafeteria of Telangana State Tourism Development Corporation lease rent were waived for Rs 2.50 Crores, and also I required in which Board minutes the Corporation has waived the lease rent of Durgaram Chervu with certified Xerox copy.
- b) Kindly supply the information that the Hon'ble Minister of Tourism Sri. Srinivas Goud Garu 10th day ceremony of his father was held in home town Mahabubnagar District. So on this occasion the Managing Director of State Tourism Development Corporation Ltd Sri. B. Manohar Rao has provided three Vehicles along with Cook/Waiter/other staffs for three days, and the Kitchen equipment/Provision including Vegetable, Non-Vegetarian transported from Hyderabad to Mahabubnagar. Now I required the money receipt of three vehicles hirer and catering charges for three days.
- c) Kindly supply the information that I required the three Buses numbers/Log Sheet No/Name of the Driver/Time check out from Garage/Time check in & date of which was hired/ complimentary given to Ministry of Tourism of Telangana Sri. Srinivas Goud on the occasion of his 10th day ceremony in the month of Feb-21 as prescribe below:

- d) Kindly supply the information that I required the Name of firms to whom Capital Repair / Maintenance works Contract given for Rs 1 Lakhs upto 10 Lakhs of Hotels/Water Fleet/Eco-Tourism of State Tourism Development Corporation Ltd for the period from June 2014 to February 2018 as prescribe below:

- i) Kindly supply the information that there is no marketing staff in the TSTDC.
- j) Kindly supply the information that there is any deal between the in-charge Managing Director Sri. B. Manohar Rao with Ravindra Naik beans the Public Relation Officer of RTI and Shanti Samadham who is in-charge of General Manager (F) permanent employees of TSTDDC.

- k) Kindly supply the information that I required the Name of firms to whom Capital Repair / Maintenance works Contract given for Rs 1 Lakhs upto 10 Lakhs of Hotels/Water Fleet/Eco-Tourism of State Tourism Development Corporation Ltd for the period from March 2018 to February 2021 as prescribe below:

- o) Kindly supply the information that I required the lease rent received details of Durgaram Chervu Lease of Restaurant from the date of lease out and also required monthly lease rent.

The Public Information Officer through Letter dated 06-03-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ Telangana State Tourism Development Corporation, Himayathnagar, Hyderabad and requested to provide information to the applicant directly under intimation to their office.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Case was heard on 05-01-2022. The complainant is present and stated that the PIO has not furnished the sought information. The PIO/Sri N.Ravinder Naik, Assistant General Manager(Admin), O/o the Telangana State Tourism Development Corporation, Hyderabad is present and submitted his affidavit stating that since the information sought by the complainant was furnished many times, the present 6(1) application was rejected by their office. The PIO also stated that vide letter Lr.No.TSTDC/RTI/08/21/2021, dated.03-04-2021 the same was informed to the complainant through registered post.

Heard both the parties and perused the material papers available on record. The Commission noticed that the above complainant is a regular RTI appellant seeking the same information from public authority i.e., from the Telangana State Tourism Development Corporation the PIO has rejected the present 6(1) application.

Hence the Commission advises the complainant not to repeat the same in the future.

The Commission also directs the PIO to furnish the information to the complainant within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
