Order

Sri Mohammed Abdul Gaffar has filed second appeal dated **11-05-2021** which was received by this Commission on **11-05-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad and the First Appellate Authority/ O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **16-09-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

This is to bring to your kind notice that SRI. Mohammed Abdul Gaffar S/O. Mohammed Abdul Sattar, R/o. H.No. 12-11-850/A, Ambernagar, Warisguda, Sec,bad requested filed under RTI Act, 2005 requested to Furnish Connected records along with in resecept of Lr. No. R1/1122/2020 dt. 07-09-2020 hearing before the Appellate Authority and the Information commission on 26-07-2018 required to notice issue for certified copies of SHAHI FIRMAN dt. 2nd Jamadiul Awwal, 1355. Requested you to kindly considering my appeal dt. 11-09-2019 Memo No. C5/1649612472/2019 DT. 16-09-2019 Advised to approach the concerned Appellate Authority in the office of the State Archieves. & Research Institute, Tarnaka. Requested to arrange my case certified copy. I will pay required fee for above transaction. I shall pay required fee of Rs.10/- Court fee for above transaction

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **01-02-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Case was heard on 05-01-2022. The appellant is present and stated that PIO has not furnished the information. The PIO/Smt.Sayeeda Sultana, Archivist, O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad is present and stated that a letter Lr.No.R1/1222/F/2020, Dated.05-10-2020 was furnished personally to the appellant stating that as per furnished particulars the records sought by the appellant is not available in their office.

Heard both the parties and perused the material papers available on record. The Commission observed that since the appellant has not mentioned the records details properly the PIO was unable to furnish the information.

However the Commission directs the Public Information Officer to collect the correct details from the appellant and furnish the information within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
