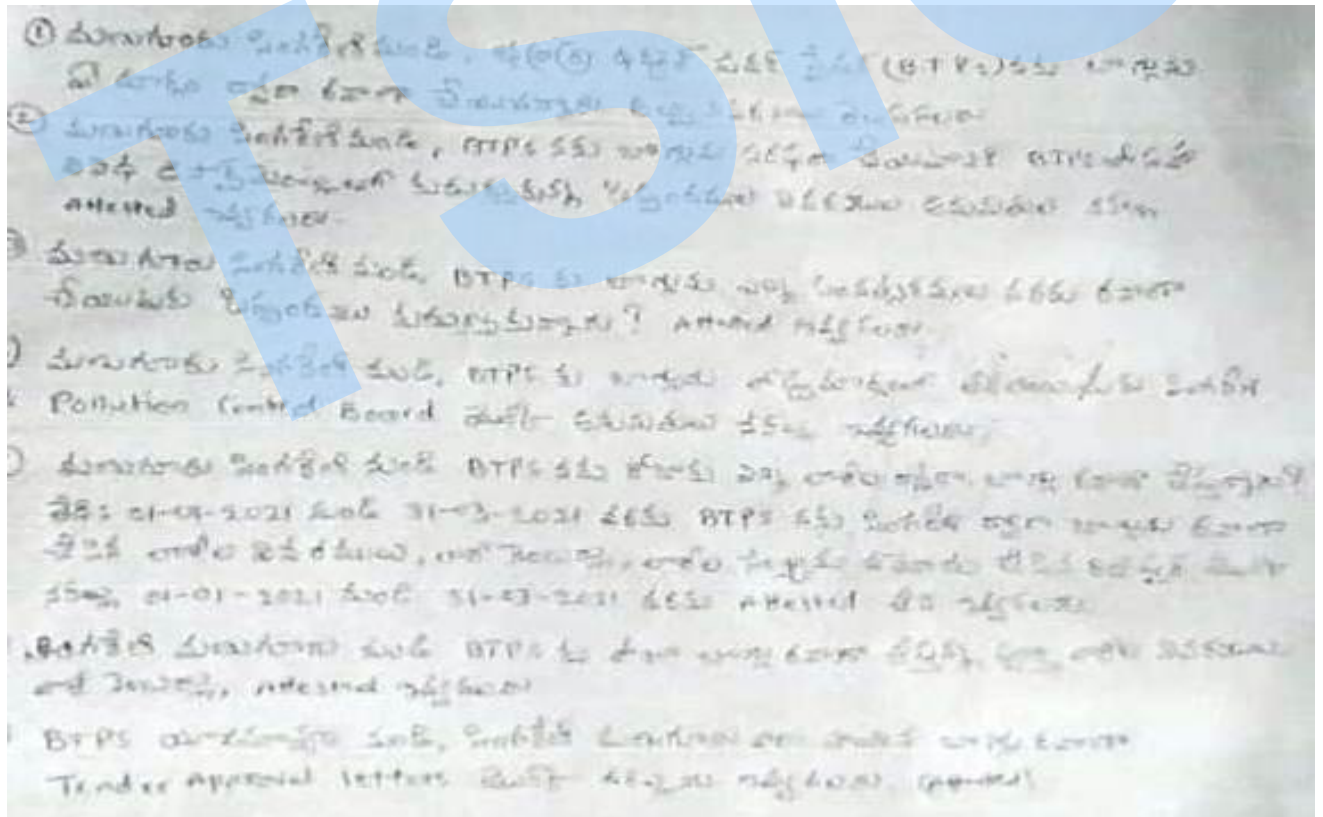

Order

Sri B. Laxman Rao has filed complaint dated **06-05-2021** which was received by this Commission on **12-05-2021** for not getting the information sought by him from the Public Information Officer/ O/o the SCCL, Manuguru Area, Bhadradri – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **31-03-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:



Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-02-2022 at 10.30 AM.**

The Case is heard on 23-02-2022. The complainant is absent. The PIO/Sri S.Ramesh, Dy.General Manager(Per), O/o the SCCL, Manuguru Area, Bhadradi Kothagudem District is present and stated that the complainant is seeking information for 7 points and vide letter Ref.No.MNG/PER/RTI/1/1187, dated. 04-06-2021 the information for point No.7 was furnished to the complainant and for remaining information the complainant was informed that he may obtain the same from Chief Engineer, TSGENCO. Hyderabad.

The PIO/Sri K.Venkateswara Rao, Dy.Secretary(Estt.), O/o. TSGENCO, Hyderabad is present and submitted that vide letter Lr.No.Dir(HR)/DS(Estt.)&PIO/DM(HR)(RTI&PR)/PO.N/824/2021-4, dated. 05-08-2021 the information for point No.1& 4 was furnished to the complainant and for remaining information the complainant was informed that the information pertains to trade secrets & commercial confidence and the complainant has failed to establish any public interest in seeking the same, hence the same is exempted from furnishing as per Section 8(1)(d) of RTI Act, 2005.

Heard the PIO's and perused the material papers available on record. The Commission observed that the PIOs has furnished part information to the complainant and rejected to furnish the remaining information as per section 8(1)(d) of RTI Act, 2005.

The Commission directs the PIO/ O/o. TSGENCO, Hyderabad to furnish the information relating to the lorries numbers sought by the complainant through his 6(1) application within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
