<u>Order</u>

Sri G. Srinivasa Rao has filed complaint dated **08-08-2020** which was received by this Commission on **12-08-2020** for not getting the information sought by him from the Public Information Officer/ The District Revenue Officer, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **02-07-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **18-01-2022 at 10.30 AM**.

The Case was heard on 18-01-2022. The complainant is absent. The PIO/Sri S.Linganandam, Assistant Director, O/o the District Educational Officer, Medchal Malkajgiri District is present and submitted his affidavit stating that vide letter Lr.Rc.No.62/A3/RTI/2020, dated.03-09-2020 the complainant was informed that at present there is a stay on the G.O by the Hon'ble High Court, Hyderabad about the execution of G.O.Ms.No.42, School Education, dated.30-07-2010. The PIO further stated that the Commission in its earlier Complaint No.6506/SIC-MNR/2020, dated.10-08-2021 has also directed the PIO to furnish the information immediately after the receipt of the final orders from the Hon'ble High Court, Hyderabad and the same is still pending.

Heard the PIO and perused the material papers available on record. The Commission observed that since there is a stay on the execution of G.O Ms.No.42 Sch.Edu Dated: 30-07-2010 by the Hon'ble High Court, Hyderabad the PIO was unable to furnish the information.

Hence the Commission directs the PIO to furnish the information immediately after the receipt of final orders from the Hon'ble High Court, Hyderabad.

With the above direction, the complaint is closed.
