## **Order**

Sri G. Narender Rajan has filed second appeal dated **11-08-2020** which was received by this Commission on **20-08-2020** for not getting the information sought by him from the Public Information Officer/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad and the First Appellate Authority/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **30-01-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Kindly provide district wise list of contract staff nurses working under DPH&FW Telangana.
- 2) Please inform whether Nursing Superintendent Grade-1 and Grade-2 working in Telangana Govt Hospitals are Gazetted rank or not. If not according to which G.O. they are not considered as Gaazetted.
- 3) Kindly inform the current status of implementation of Central Govt order of implementing the Staff Nurse Nomenclature as Nursing Officer as per Ministry of health and family welfare Nursing section Central Govt order Z.28015/41/2014-N. Dt 9sep 2016.
- 4) Please inform the current status of the Recruitment process of Staff Nurse posts as per G.O mentioned below
  - a)G.O.Ms No.46 dt:26-06-2019
  - b)G.O Ms No.88 dt:19-05-2017
  - c)G.O Ms No.27 dt: 14-02-2017
  - d)G.O.Ms No.119 dt: 13-07-2017
  - e)HMand FW(A1)Dept Note No:5669/A1/2016 dt:04-05-2017
- 5) Kindly inform whether the MLHP can be promoted /posted as CHO in Telangana Govt hospitals/PHC/Sub center if so as per which G.O mention it.
- 6) Please furnish relevant supporting documents in favor of your responses.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **14-03-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The appellant is present and through affidavit stated that the PIO has furnished the information on the day of hearing. The APIO/Sri M.Surender Reddy, Assistant Secretary to Government, Health Medical & Family Welfare Department, TS Secretariat, Hyderabad is present and stated that the information sought by the appellant is furnished before the Commission. The PIO further stated that since the information sought by the appellant was furnished by Director of Public Health and Family Welfare there is a delay in furnishing the information.

Heard both the parties and perused the material papers available on record. The Commission observed that the appellant stated that he has received the complete information.

Since the information is furnished, the appeal is closed.
