Order

Sri K. Dharmender has filed second appeal dated **21-08-2020** which was received by this Commission on **21-08-2020** for not getting the information sought by him from the Public Information Officer/ The District Revenue Officer, Medchal – Malkajgiri District and the First Appellate Authority/ The Joint Collector, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **18-02-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **13-07-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **18-01-2022 at 10.30 AM.**

The Case was heard on 18-01-2022. The appellant is present and stated that the PIO has not furnished the information. The APIO/Sri E.Saidi Reddy, Naib Tahsildar, O/o. the District Revenue Officer, Medchal Malkajgiri District is present and submitted a letter Lr.No.D1/141/2020, dated.17-01-2022 stating that the grievance of the appellant is to update the revenue records, but in the light of revised ROR Act, any grievance related to land matter required to be raised in Dharani Portal in appropriate module for redressel of grievance. Since various options and provisions are in continuous process of updation in the Dharani Portal, the grievance sought by the appellant is not available presently and he may raise the same after availability of such option in the Dharani Portal and the same was informed to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that since there is no option available for updation of the records in the Dharani Postal the PIO was unable to provide the sought information to the appellant.

In view of the above, the appeal is closed.
