## Order

Sri MD. Naheem Pasha has filed second appeal dated **31-05-2021** which was received by this Commission on **05-06-2021** for not getting the information sought by him from the Public Information Officer/ O/o the General Manager, SCCL., Srirampur Area, Mancherial District and the First Appellate Authority/ O/o the General Manager, SCCL., Srirampur Area, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **16-01-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Srirampur Area Office వరకు ఇచ్చి దివాలా లాభం  
Open cost protect and Coal transport and contract

order copies and contractor, company కి చిట్ట

- 2) ఈ విషయం Coal transport and contract start  
లాండ్ వంటివి, January 2021 వరకు ఎక్స్‌టెన్షన్ - అవకాశం  
ఇవ్వాలి తెలుసు, అవకాశం పొందే తెలుసు, ఈ విషయం  
Vehicle విషయం RC copies ఇవ్వాలి.
- 3) ఈ coal transport విషయం, ఈ company ఎంత  
measurement - ఎక్స్ అవకాశం పొందే తెలుసు అవకాశం  
పొందే ఇవ్వాలి.
- 4) ఈ విషయం transporter or contractor, labour depart-  
ment of central వంటివి తెలుసు, labour license  
copy ఇవ్వాలి, ఆ పేరు contract labour act 1970,  
section 1(4).
- 5) ఈ విషయం contractor, labour department వంటివి  
license తెలుసు, contract work permission ఇవ్వాలి  
అవకాశం పొందే తెలుసు, అవకాశం పొందే తెలుసు  
work permission ఇవ్వాలి, ఈ విషయం తెలుసు.

## **More (5) points.**

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **26-03-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-02-2022 at 10.30 AM.**

The Case is heard on 15-02-2022. The appellant is present and stated the PIO has not furnished the information. Sri M.Rajesh, Sr.Personnel Officer on behalf of the PIO/DGM(Per), SCCL, Srirampur Area, Mancherial District is present and stated that vide Ref.No.SRP/PER/25.000/4551, dated.26-07-2021 the appellant was informed that the information sought by him does not fall under Section 2(f) of RTI Act, 2005. The PIO also submitted a copy of the letter along with the copy of the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has not furnished the sought information to the appellant. The Commission warns the PIO not to repeat the same in the future and strictly adhere to the provisions of RTI Act, 2005.

The Commission did not accept the plea made by the PIO and directs the PIO to furnish the information to the appellant following the guidelines of Section 8, 9, 10 & 11 of RTI Act, 2005 within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
