Order

Sri MD. Naheem Pasha has filed second appeal dated **31-05-2021** which was received by this Commission on **05-06-2021** for not getting the information sought by him from the Public Information Officer/ O/o the General Manager, SCCL., Srirampur Area, Mancherial District and the First Appellate Authority/ O/o the General Manager, SCCL., Srirampur Area, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **22-05-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Srirampur Office అధికారులకు Sahaya mineకు ప్లాన్లు మరియు పుస్తకం పోలీసు Transport Contract ఎంబీ 223306 పై contract order Agreement copyలను ఇవ్వండి
- 2) ఈ ప్లాన్ల contract POB Transport పుస్తకం లోని measurement పైకి అందుతున్న సొల్లి, ఎంబీ 223306 ఇవ్వండి.
- 3) ఈ ప్లాన్ల contractor కి లాబర్ల పోలీసు POB Transport పైకి ఎంబీ 223306 అందుతున్న పుస్తకం లోని measurement పైకి ఇవ్వండి. 3 months salary, copy of epf details (Applicant), February, March 2020, ఇవ్వండి.
- 4) ఈ ప్లాన్ల contractor, లాబర్ల department నుండి ప్లాన్లకు labour lixure copy ఇవ్వండి. పుస్తకం లోని ఎంబీ 223306 loading point పుస్తకం పైకి SRIPUR 193, RK-7, 8 mine కి load ఎంబీ 223306 ఇవ్వండి. Route map (Normal) ఇవ్వండి.
- 5) ఈ ప్లాన్ల contractor కి లాబర్ల పోలీసు పుస్తకం లోని medical records & documents Records & A, B registers. పుస్తకం లోని ఎంబీ 223306 ఇవ్వండి. పుస్తకం లోని ఎంబీ 223306 ఇవ్వండి.

The Public Information Officer through Letter dated 20-06-2020 informed to the appellant that the application is forwarded to concerned mines for obtaining information and it may require some more time.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **21-07-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-02-2022 at 10.30 AM.**

The Case is heard on 15-02-2022. The appellant is present and stated the PIO has not furnished the information. Sri M.Rajesh, Sr.Personnel Officer on behalf of the PIO/Sri P.Govinda Raju, DGM(Per), SCCL, Srirampur Area, Mancherial District is present and requested the Commission to provide them 15 days of time to furnish the information to the appellant..

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has not furnished the information to the appellant. The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
