Order

Sri B. Kishore has filed second appeal dated **31-05-2021** which was received by this Commission on **07-06-2021** for not getting the information sought by him from the Public Information Officer/ O/o the SCCL., Kothagudem, Bhadradi – Kothagudem District and the First Appellate Authority/ O/o the SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **28-02-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- ❖ శ్రీ లంబడి గోల్లియా S/O వెంకట్య గారు తమ సింగరేణి యందు వాచ్మెన్ గా పని చేస్తూ 1969 ఏప్రిల్ నందు No .SPC /63/936/70 తది 19.11.1970 ద్వారా వాలంటరీ రిటైర్మెంట్ అయినరు, దీనికి సంబంధించిన నకలు జత చేయుచున్నను .
- ❖ పైన తెలిపిన గోల్లియా మా ముఖ్యత కావున RTI act 2005 ప్రకారం సమాచారం ఇవ్వగలరు.
- 1. మా ముఖ్యత గోల్లియా అపాయింట్మెంట్ కు సంబంధించిన వివరాలు ,జాయిన్ అయిన సంవత్సరం తదితర సమాచారం ధ్రువీకరణ పత్రం ఇవ్వగలరు.
- 2. ఈ పై సమాచారంతో పాటు పౌర సమాచార అధికారి , సహాయ సమాచార అధికారి ,అప్పీలేట్ అధికారి పేర్లు ,హోదా,ఫోన్ నెంబర్ ఇవ్వగలరు.

The Public Information Officer through Letter dated 08-03-2021 informed to the applicant that the information sought by the applicant is of 50 years old which is not available in their office. Therefore, the application is returned herewith.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **27-03-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 03-04-2021 requested the Public Information Officer to furnish the sought information to the appellant under intimation to their office.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-02-2022 at 10.30 AM.**

The Case is heard on 23-02-2022. The appellant is present and through affidavit stated that the PIO has not furnished the sought information till date. The PIO/Sri D,Srinivas, Dy.GM, Corporate, Kothagudem Area, Bhadradi Kothagudem District is present and stated that vide Ref No.CRP/RTI-PIO/G.C./332, dated. 08-03-2021 the appellant was informed that the information sought by him is of 50 years old record which is not available at their office and the same cannot be dispensed. The PIO further submitted a copy of the letter along with the copy of the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record. The Commission observed that the information sought by the appellant is relating to more than 50 years old record.

The Commission is of the view that as per Office Memorandum No1/14/2007-IR, Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, New Delhi, dated.31st October, 2007 the information sought may be exempted if 20 years have lapsed after occurrence of the incident to which the information relates.

Keeping in view of the above, the appeal is closed.
