## Order

Sri GK. Sampath Kumar has filed second appeal dated **09-09-2020** which was received by this Commission on **10-09-2020** for not getting the information sought by him from the Public Information Officer/ The DGM (Per), O/o the SCCL., Kothagudem Area, Bhadradi – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **17-06-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

for an amount of Rs 101-...  
under Section 6(1).

I am furnishing here under the document number,  
date, cheque number and amount:  
Document NO: 22022519 dt: 22-6-2016 (61)  
Cheque Number: 523883, dt: 22-6-2016  
Amount: 141,824 (one lakh forty one thousand eight  
hundred and twenty four rupees only)

Please arrange to furnish the name of the Bank,  
~~Bank A/c Number~~ Bank A/c Number, Payment released on whose  
name and furnish the purpose for payment.  
Sri G.K. Sampath Kumar is having right to know  
Public Section and every citizen is having right to know  
the information. Hiding such information by the concerned  
will lead to supporting the misuse of Public Funds.

The Public Information Officer through Letter dated 08-07-2019 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **10-07-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No.CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of “Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is absent. The PIO/Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and submitted that vide letter Ref.No.CRP/RTI-PIO/3058/708, dated.07-09-2020 the appellant was informed that the since the information sought by him qualifies to be the personal and third party information and the same is rejected under Section 8(1)(j) of RTI Act, 2005.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has rejected to furnished the information to the appellant following Section 8(1)(j) of RTI Act, 2005 and moreover the information sought is not specific.

Hence the Commission advises the appellant to seek specific information by filing a separate 6(1) application before the concerned PIO.

In view of the above, the appeal is closed.
