## **Order**

Sri GK. Sampath Kumar has filed second appeal dated **09-09-2020** which was received by this Commission on **10-09-2020** for not getting the information sought by him from the Public Information Officer/ The DGM (Per), O/o the SCCL., Kothagudem Area, Bhadradi – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **22-06-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Please refer to the order dated 22-07-2020 wherein it is furnished for point no: 5(i) for the year 2014-15, 15-16, 16-17, 17-18, 18-19 & 19-20.

① Please arrange to furnish the number of Banks / name of the Banks submitted quotations of Rate of interest for the year 2014-15, 2015-16, 2016-17, 2017-18, 2018-19 and 2019-20.

② Please arrange to furnish the number of Banks / name of the Banks for the year 2018 and 2019.

③ Please arrange to supply the rate of interest quoted by other Banks and YES Bank for 300 and 1300 rates.

④ Please arrange to supply a copy of note connected to comparative statement of the deposits in YES Bank for the year 2018 and 2019.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **22-07-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No.CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of “Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Cases were heard on 11-01-2022. The appellant is absent. The PIO/ Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and stated that vide letter Ref No.CRP/RTI-PIO/3072/573, dated.06-08-2020 the information sought was furnished to the appellant through registered post. The PIO further submitted a copy of the information along with the copy of the postal acknowledgement.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeals are closed.
