## **Order**

Sri E. Ch. Rangaiah has filed complaint dated **07-09-2020** which was received by this Commission on **10-09-2020** for not getting the information sought by him from the Public Information Officer/ The Addl. Collector, Urban Local Bodies, O/o the District Collector, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **06-07-2020** before the Public Information Officer/ O/o the District Collector, Medchal – Malkajgiri District requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

**Ref: My letter dated 17-05-2020.**

**With reference to the above cited letter, I have submitted call records and document evidence regarding fraud in Municipality office, Kompally through mail, but no action is taken so far. Hence please give me information regarding action on people who made the fraud in Municipal office, Kompally under RTI Act-2005.**

The Public Information Officer through Letter dated 16-07-2020 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the Addl. Collector, Urban Local Bodies, Medchal – Malkajgiri District to provide the information directly to the complainant through RPAD under intimation to their office.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **18-01-2022 at 10.30 AM.**

The Cases were heard on 18-01-2022. The complainant is absent. Sri K.Bhaskar, CC to Additional Collector, Medchal Malkajgiri District is present and submitted that the information sought by the complainant pertains to the Commissioner, Kompally Municipality and vide letter Lr.No.2193/KMC/2021, dated.06-01-2022 the Commissioner, Kompally Municipality has furnished the available information to the complainant through registered post. The PIO further submitted a copy of the letter along with the copy of the acknowledgement before the Commission.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the available information to the complainant.

Since the available information was furnished, the complaint is closed.
