Order

Sri Mohd. Ibrahim has filed second appeal dated **16-06-2021** which was received by this Commission on **21-06-2021** for not getting the information sought by him from the Public Information Officer/ O/o the General Manager, SCCL., Ramagundam-I, Godavarikhani, Peddapalli District and the First Appellate Authority/ O/o the General Manager, SCCL., Ramagundam-I, Godavarikhani, Peddapalli.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **30-01-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

రాజ్ కలెక్షన్ల సేవలను అందించే స/ం అధికారులను, వారు సేవలను అందించే స/ం అధికారులను, II A క్లస్టర్ అధికారులను సేవలను అందించే అధికారులను అభ్యంతరం జి.జం.కలెక్షన్ 72-2 (H.No:-7-1-2/16) అండ్ ఈ విషయం దేవులు, అతని నామం కింద, అతని సహాయించి వారూ సేవలను అందించారు. ముందు సహాయించి వారూ సేవలను అందించారు అంటే కింద విషయం సరే అంటే వారు సహాయించే సేవలు అందించారు.

The Public Information Officer through Ref: RG1/ED/RT1-390/555 dated 23-02-2021furnished the available information to the appellant through Ref dated 17-02-2021.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **13-03-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Ref dated 15-04-2021 requested the appellant and the Public Information Officer to attend for hearing on 29-04-2021 at 4.00 PM along with related records/ documents.

The First Appellate Authority through Ref dated 30-04-2021 informed to the Appellant that the Public Information Officer has already sent available information through Letter dated 23-02-2021. Hence, the appeal is disposed off accordingly.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-02-2022 at 10.30 AM.**

The Case is heard on 15-02-2022. The appellant is present and stated that the PIO has not furnished the information. The PIO/ Sri A.Annjaneyulu, Dy.General Manager(E), SCCL, Ramagundam-1, Godavarikhani, Peddapalli District is present and stated that the appellant is seeking personal information of a third party and vide letter Ref:RG1/IED/RTI-390/555, dated.23-02-2021 the appellant was informed that the third party vide his letter dated.17-02-2021 has not accepted to furnish his personal details to the appellant. The PIO further submitted a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record. The Commission observed that though the information sought by the appellant is personal information of a third party but the appellant claims that the information sought is a remedy for his grievance.

Hence the Commission directs the PIO to furnish a detailed report regarding the information sought by the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
