Order

Sri K. Tej Rao has filed complaint dated **10-09-2020** which was received by this Commission on **17-09-2020** for not getting the information sought by him from the Public Information Officer/ O/o the Director of PH&FW, Koti, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **01-09-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

I wish to know about the following facts.

- a) Date of official retirements of under mentioned staffs
 - i) P. Ramchader Rao
 - ii) N. Gopal Reddy
 - iii) D. Narsingh Rao
 - iv) Md. Sujat Ali Khan
 - v) M.A. Hakeem
 - vi) K. Tej Rao (My self)
- b) Pay last drawn for the above said employees as per department records.
- c) Designation of above said employees last working status
- d) Working (Calculations)of pay differences as per the Order of Hon'ble The Addl. Industrial Tribunal Cum Additional Labour Court, Hyderabad vide M.P. No. 9/98 Dt. 14th September 2001 has confirmed by Hon'ble High Court of judicature, Andhra Pradesh vide W.P. No. 24867/2001 Dt. 12-09-2008.
- e) Details of pay scale forwarded to Pension department as per records for the above said employees.
- f) Whether any further dispute is pending for the above said employee No. VI pending for clarification in regards to forwarding pension department.
- g) Payment of Difference of pay (Arrears) after the Order of Hon'ble High court order for the above said employees.
- h) Whether any difference in payment of pay after the order of the Hon'ble High Court and reason for the variation (if any).
- i) Any clarification pending to forward pension department on behalf of above said employee No.VI.
- j) Copy of all Undertakings if any are provided by the said employees at the time of disbursal of difference of pay after the Memo No. 22129/F1/2002 Dt. 19-04-2010 till final compliances.
- k) Copy of all the correspondences after the Memo No. 22129/F1/2002 Dt. 19-04-2010 till final compliances.
- l) Details of Lr. R.C. No.YIA/10824/2001 Dated 05-02-2000 with regards to above said all employees.
- m) Details of Automatic Advancement Scheme and why not applicable to me (Grounds)
- n) Details of Loss occurred on not giving any promotions, but 16 years scale given.
- o) Facts and descriptions of departmental, disciplinary proceeding any pending on against me.

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The complainant is absent. The PIO/ Sri B.Thirupaiah, SHT Officer, State Health Transport Organization, Hyderabad is present and stated that vide letter Lr.Rc.No.01/RTI/SHTO/2020, dated. 05-11-2020 the appellant was informed that the some of the records are available at their office and requested the complainant to visit their office and seek the information. The PIO further stated that the complainant has visited their office and verified the records but since the complainant was an uneducated, asked to give rough papers but the PIO refused to give hence the complainant has not received the information. The PIO also stated that vide Lr.Rc.No.01/RTI/SHTO/2020, dated.11-12-2020 the appellant was once again asked to pay a DD of Rs.1380/- for obtaining the sought information. But since the complainant failed to comply he has not received the information.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has not furnished the information to the complainant. The Commission warns the PIO not to repeat the same in the future and furnish the information as per the provisions of the RTI Act 2005.

The Commission also directs the PIO to once again call the complainant for verification of records as per Section 2(j) of RTI Act by issuing a prior intimation to the complainant and furnish the sought information within one week and to report compliance to the Commission.

With the above direction, the complaint is closed.
