<u>Order</u>

Sri S. Ramesh has filed second appeal dated **23-06-2021** which was received by this Commission on **24-06-2021** for not getting the information sought by him from the Public Information Officer/ O/o the District Educational Officer, Medchal – Malkajgiri District and the First Appellate Authority/ the District Educational Officer, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **22-02-2021** before the Public Information Officer/Dy. Educational Officer, Kukatpally, Hyderabad requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **29-03-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The District Educational Officer, Hyderabad through Letter dated 23-04-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ District Educational Officer, Rangareddy District and requested to furnish the available information to the appellant.

The District Educational Officer, Rangareddy District through Letter dated

28-05-2021 transferred the application under section 6(3) of RTI Act, 2005 to the

Public Information Officer./ District Educational Officer, Medchal - Malkajgiri

District and requested to furnish the sought information to the applicant under

intimation to their office.

Stating that the appellant did not get any response from the First Appellate

Authority, he preferred this 2nd appeal before this Commission requesting to

arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing

on **22-02-2022** at **10.30** AM.

The Case is heard on 22-02-2022. The appellant is absent. The PIO/ Sri

S.Linganandam, Assistant Director, O/o the DEO, Medchal Malkajgiri District is

present and stated that the 6(1) application filed by the appellant was transferred

to the Mandal Educational Officer, Kukatpally, Medchal Malkajgiri District vide

Lr.No.25/A3/RTI/2021, dated.14-06-2021 to furnish the information to the

appellant. The PIO further filed a copy of the letter along with the copy of the postal

receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO/ Mandal Educational Officer, Kukatpally,

Medchal Malkajgiri District to furnish the information to the appellant within one

week from the date of receipt of this order through RPAD and to report compliance

to the Commission.

With the above direction, the appeal is closed.
