Order

Sri S. Naveen Kumar has filed second appeal dated **25-09-2020** which was received by this Commission on **29-09-2020** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Medchal Mandal, Malkajgiri, Medchal – Malkajgiri District and the First Appellate Authority/ The Revenue Divisional Officer, Keesara Division, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **11-06-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **24-08-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **19-01-2022 at 10.30 AM.**

The Case is heard on 19-01-2022. The appellant is absent. The APIO/Sri Ch.Chandrakanth, Girdawar, Medchal Mandal, Medchal Malkajgiri District is present and stated that vide letter No.RTI/10/2022-12, dated.18-01-2021 the information sought by the appellant was furnished personally in their office. The PIO further submitted a copy of the letter personally endorsed by the appellant stating that the information sought is received by him.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
