Order

Sri Mohammed Abdul Gaffar has filed second appeal dated **02-07-2021** which was received by this Commission on **03-07-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad and the First Appellate Authority/ O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **16-04-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

I, the undersigned would like to inform you the following few lines for kind consideration and concerned authority that I need information with regard to certified copies of Muntakab No.2643 dated 31 Amardad 1300 Fasli or 1890 A.D), Muntakab No.98 dated 27.11.1958, Farman Mubarak 1st Ramzan, 1333 Fasli in respect of Judgement of Maharaja Sir Kishan Pershad dated 31st Thir 1332F and please furnish full details and copies as it is urgently required for my record purpose.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **11-05-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Case was heard on 05-01-2022. The appellant is present and stated that the PIO has not furnished the information. The PIO/Smt.Sayeeda Sultana, Archivist, O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad is present and stated that vide letter Lr.No.R1/909/MUN/2021, Dated.10-06-2021 the information sought was furnished by collecting the requisite charges from the appellant. The PIO further submitted a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has failed to provide the copy of the information before the Commission and also no proof of acknowledgement from the appellant stating that the information is received by him.

However the Commission directs the Public Information Officer to furnish the information once again to the appellant within one week through RPAD to report compliance to the Commission.

With the above direction, the appeal is closed.
