Order

Sri B. Murali Mohan has filed complaint dated **05-07-2021** which was received by this Commission on **06-07-2021** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Mahabubnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **06-02-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The Case is heard on 22-03-2022. The complainant is absent. Sri M.Anil Kumar, Senior Assistant on behalf of the PIO/Dr.B.Bhasker Naik, Administrative Officer, O/o the DM & HO, Mahabubnagar District is present and stated that vide letter Rc.No.189/RTI/2022, dated.04-03-2022 the available information was furnished to the complainant. The PIO also filed a copy of the information along with the copy of the postal acknowledgement.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the available information to the appellant but with an abnormal delay.

The Commission took a serious view against Public Information Officer for not furnishing the information to the complainant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
