## **Order**

Sri G. Venkatesh has filed second appeal dated **08-07-2021** which was received by this Commission on **13-07-2021** for not getting the information sought by him from the Public Information Officer/ O/o the President – Telangana Weightlifting Association, Nizamabad District and the First Appellate Authority/ O/o the President – Telangana Weightlifting Association, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **30-12-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

**Sub:- Request to the information officer to provide information according to Right To Information Act 2005 sec 6(i) under sec 4(4) Please provide the authorised documents.**

**I G Venkatesh s/o G Laxminarayana R/o Hyderabad.**

**Request you to please provide documents related Weightlifting Association Medak District affiliated to TWLA.**

1. As per the guidelines issued by TWLA Letter dated 07.06.2019. regarding bifurcation of all the districts of Telangana State by end date 31.07.2019. Please provide the attested documents of Medak bifurcation district.
2. Before end date how many members submitted their applications for bifurcated of Medak District.
3. When and where the elections conducted and also the election process of bifurcated Medak District provide Attested documents.
4. Bye-laws and minutes of meetings from the date of registration.
5. How the Medak District is eligible for elections of TWLA in the year 4th-May-2019.
6. We have already complained plenty of times please respond (mail copy attached).  
Kindly provide all the attested documents.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **30-01-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Cases were heard on 05-01-2022. The appellant is present and stated that the PIO has not furnished the information. The PIO/Sri D.Sailoo, President, Telangana Weight Lifting Association, Nizamabad District is present and submitted vide letter dated.26-04-2021 the available information was furnished to the appellant and for remaining information informed the appellant that a letter dated.03-03-2021 was forwarded to the General Secretary, Medak District Weightlifting Association to furnish the remaining information to the appellant, since there was no reply from the General Secretary they were unable to furnish the complete information to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the available information to the complainant.

The Commission also directs the PIO to collect the remaining information and furnish the same to the appellant within two weeks and to report compliance to the Commission.

With the above direction, the appeal is closed.
