Order

Sri Mohd Yousuf Khan has filed second appeal dated **13-07-2021** which was received by this Commission on **14-07-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC, Chandanagar, Ranga Reddy District and the First Appellate Authority/ O/o the Deputy Commissioner, GHMC, Chandanagar, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **22-12-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Sub : Please furnish the copies on which ground the name has been change from Mohd Khan to Mazeed Property as per G.H.M.C office record dated: 11-6-1996 the name mention in Municipal Property Tax Receipt as Mohd khan H.NO: 1-58/1/A,B,C,D and dated 23-11-2006 the name mention in Municipal Property Tax Receipt as Mazeed Property Door No: 1-58/1/A & B & C & D & E & F & G . Miyapur Village, Serilingampally Mandal, RangaReddy District.

I am Mohd Yousuf Khan S/o Mohd Khan H.No : 1-49/1/12
Miyapur village, Serilingampally Mandal, RangaReddy District,
Telangana State, Pincode:500049,

I submit that acknowledgement in tax receipt, Dated 23-11-2006 if any difference found in this demand notice the tax payers are requested to bring the previous receipt at the time of payment for rectification. InConvenience is sincerely regretted.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **02-02-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-03-2022 at 10.30 AM.**

The Case is heard on 09-03-2022. The appellant is absent. The APIO/ Sri Waheed Ali, Assistant Municipal Commissioner, Circle-21, Chandanagar, Serilingampally Zone is present and stated that vide letter dated. Nil the appellant was informed to bring the original payment receipts within a week for verification of Authenticity of the case. The PIO further submitted a copy of the letter along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the appellant by collecting the receipts from the appellant within two weeks through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
