## Order

Sri T. Akulaiah has filed complaint dated **14-07-2021** which was received by this Commission on **17-07-2021** for not getting the information sought by him from the Public Information Officer/ O/o the PHC., Vinayakapuram, Aswaraopeta Mandal, Bhadradri – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **12-08-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. జి. 3-6-2020. నాడు చదు కార్తలయిల్ల కుర్రాస్తు పేర్లెడియ? రాని పై రానిపై తివసతి తివోర్లు. ఇవ్వకలదు.
2. చదు కార్తలయిల్ల వొరవ ముఖ్య. విద్యార్థులు ఉన్నాకలి. వారి పూర్తి సమాచారం. ఇవ్వకలదు.
3. ఖంక. సంగ. మంజీ. చదు కార్తలయిల్ల. పని-చిప్పూని పోయింది. ప్రధాన కార్తల తివోర్లు. మతియి. ఖ్యాం తివోర్లు కావాలి. చివోర్లుగలదు.
4. ఖంక సమాచారం - 2020. వరకు సంబంధించిన తివోర్లు. తివోర్లు. సమాచారం తివోర్లు ఇవ్వకలదు.

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-03-2022 at 10.30 AM.**

The Case is heard on 23-03-2022. The complainant is present and stated that the PIO has not furnished the information till date. The PIO/ O/o the Primary Health Centre, Vinayakapuram, Aswaraopeta Mandal, Bhadradi Kothagudem District is absent.

The Commission perused the material papers available on record and observed that the PIO has not furnished the information to the complainant and was also absent for hearing even after the receipt of notice from the Commission. The Commission took a serious view against the PIO and directs to issue **Show Cause Notice** to the PIO for not furnishing the information to the complainant and also for his absence.

The Commission also directs the PIO to furnish the information to the complainant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission. The action on **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
