Order

Sri K. Nagaraju has filed second appeal dated **15-07-2021** which was received by this Commission on **19-06-2021** for not getting the information sought by him from the Public Information Officer/ O/o the General Manager, SCCL., Mandamarri Area, Mancherial District and the First Appellate Authority/ O/o the General Manager, SCCL., Mandamarri Area, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **03-05-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. మా నాన్న గారి యొక్క **C M P F/Gratuity/Employment** కు సంబంధించిన ఆర్డర్ కాపీలు ఇవ్వగలరని ప్రార్థన.

The Public Information Officer through Letter dated 20-05-2021 the available information furnished by the Deemed Public Information Officer/ Mandamarri Area vide Letter dated 18-05-2021.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **04-06-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-02-2022 at 10.30 AM.**

The Case is heard on 15-02-2022. The appellant is present and through affidavit stated that the PIO has not provided information relating either to his employment or about the lumpsum amount. Sri K.Bhargav, Welfare Officer on behalf of the APIO/Sri S.N.Phani Kumar, Dy.SE(IE), SCCL, Mandamarri Area, Mancherial District is present and submitted that vide letter Ref.No:MMR/PER/RTI/L/066/21/3374, dated.20-05-2021 the available information sought by the appellant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal acknowledgement.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant but the appellant claims that he has not received either the lumpsum amount or the employment of his father.

The Commission directs the PIO/ Sri V.Varaprasad, Personnel Manager, SCCL, Mandamarri Area, Mancherial District to submit his explanation for not furnishing the information regarding the release of employment/lumpsum amount to the appellant within one week through RPAD and to report compliance to the Commission. If the PIO fails to follow the instructions issued, action will be initiated against the PIO as per Section 20 of RTI Act, 2005

With the above direction, the appeal is closed.
