Order

Sri D. Srinivas has filed second appeal dated **22-10-2020** which was received by this Commission on **23-10-2020** for not getting the information sought by him from the Public Information Officer/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad and the First Appellate Authority/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **01-06-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **10-09-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The appellant is absent. The PIO/ Smt.J.V.Vijaya lakshmi, Deputy Secretary to Government, Health Medical & Family Welfare Department, TS Secretariat, Hyderabad is present and stated that vide Letter No.1554/H/2020, dated.12-03-2020 the appellant was informed that vide Memo No.828/H/2020, dated.22-02-2020 his 6(1) application was transferred to the Director, NIMS, Hyderabad to examine his request and take necessary action as per rules. The PIO also filed a copy of the letter.

Heard the PIO perused the material papers available on record. The Commission observed that PIO has transferred the 6(1) application to the PIO/O/o the Director, NIMS, Hyderabad.

Hence the Commission directs the PIO/O/o the Director, NIMS, Hyderabad to furnish the information to the appellant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
