Order

Sri Mohd Abdul Gaffar has filed complaint dated **21-10-2020** which was received by this Commission on **23-10-2020** for not getting the information sought by him from the Public Information Officer/ The Revenue Divisional Officer, Malkajgiri, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **14-09-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

This is to bring to your kind notice that SRI. Mohammed Abdul Gaffar S/O. Mohammed Abdul Sattar, R/o. H. No. 12-11-850/A, Ambarnagar, Warisguda, Sec, bad request filed under RTI Act, 2005 request to furnish connected record along with in respect said Memo No. J/325/2013 dt. 19-10-2013 and 08-01-2014 and sent through registered post and got acknowledged application 6th cited through Order Lr. No. K/1742/2014 dt. 09-01-2014 order passed by the Spl.Gr. Dy. Collector & Revenue Divisional Officer for hearing on dt. 02-12-2019 by Appellate Authority & Joint collector, Medchal-Malkajgiri Dt required to issue notice for issue of Certified of copies of ORC and IMPLEMENT COPY in respect of land in Sy. No. 110 admeasuring Ac. 4-29 Guntas Ravalkole Village, Medchal-Malkajgiri District. Through APIC order Complaint No. 3047/SIC-SPR/2014 dt. 04-06-2014. Request to arrange my case certified copies. I already paid required fee for above transaction.

I am requesting your good self to please consider this application and issue me certified of copies of ORC and IMPLEMENT COPY in respect of land in Sy. No. 110 admeasuring Ac. 4-29 Guntas Ravalkole Village, Medchal-Malkajgiri District and do the needful urgently.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **18-01-2022 at 10.30 AM.**

The Case was heard on 18-01-2022. The complainant is present and stated that he has not received the ORC sought by him through his 6(1) application. Sri S.Prabhudas, Naib Tahsildar on behalf of the PIO/Revenue Divisional Officer, Malkajgiri Division, Medchal Malkajgiri District is present and stated that vide letter Lr.No.K/RTI/258/2020, Dated.14-12-2020 the information sought was furnished personally to the complainant. The PIO further submitted the copy of the letter along with the personal endorsement of the complainant.

Heard both the parties and perused the material papers available on record. The Commission observed that though the PIO has furnished the information to the complainant but the complainant claims that he has not received ORC copy sought by him through his 6(1) application dated.14-09-2020.

Hence the Commission directs the PIO to once again call the appellant for verification of record as per section 2(j) of the Act by issuing prior intimation to the complainant and furnish the remaining information following the guidelines of Section 8, 9, 10 & 11 of RTI Act within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
